# THE INTEGRATION OF EUROPEAN THIRD COUNTRIES IN THE SINGLE MARKET: THE SMALL-SIZED STATES.

Starting from the external dimension of the European integration process, the Seminar aims at examining the integration of a third country in the single market of the European Union, considering the model and experience, other than membership, of European States geographically closer to the Union, which decided to further integrate with the EU.

Taking into account the policies and objectives of the European Union in this context, special attention will be paid to European small-sized third States association with the Union, by exploring, from the point of view of San Marino, the political, economic and legal aspects, as well as the specificities of this process, in order to illustrate its development perspectives and its importance in the agenda of the Union.

The Seminar ultimately aims at offering suggestions for the necessary (political, economic and legal) reflection that should accompany such processes.

Roberto Baratta – He is presently contract Professor at the University LUISS Guido Carli in Rome. He was legal advisor to the Permanent Representative of Italy to the European Union (2006-2014) and advisor to the Diplomatic Litigation Service of the Italian Ministry of Foreign Affairs (2000-2006). Since 2014, he has been legal advisor to San Marino Government in the negotiations for the conclusion of one or more Association Agreements between the European Union and the small-sized States (Andorra, Monaco, San Marino). He wrote monographs and several articles published in national and international magazines.

Adriano Di Pietro – He is presently full Professor of Tax Law at the Faculty of Law, Alma Mater Studiorum University of Bologna, and Director of the Master in Tax Law "A.Berliri" at the University of Bologna. He is Director of some important Italian magazines specialised in tax law and he wrote monographs and several articles published in national and international magazines. He is advisor to the Ministry of Finance and the Budget of the Republic of San Marino.

Piergiorgio Valente – He is presently *President* of the *Confédération Fiscale Européenne* (CFE), *Bureau Member* of the *Taxation and Fiscal Policy Committee* of the *Business and Industry Advisory Committee* (BIAC) to the OECD, Italian Representative of Confindustria with the *Tax Policy Working Group* of BUSINESSEUROPE, *Chairman* of the International Tax Committee of the *International Association of Financial Executives Institutes* (IAFEI). He is adjunct Professor at the Link Campus University in Rome. He is the advisor to the Ministry of Foreign Affairs of the Republic of San Marino.
